CONTRACT AGREEMENT FORM

PROCUREMENT OF TWO (2) UNITS MINI BUSES AND ONE (1) UNIT MULTI-PURPOSE VEHICLE FOR THE NATIONAL DEFENSE COLLEGE OF THE PHILIPPINES

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made this NOV 2 9 2019, 2019 between the NATIONAL DEFENSE COLLEGE OF THE PHILIPPINES, a government instrumentality duly established and existing under and by virtue of the laws of the Republic of the Philippines with office address at Camp General Emilio Aguinaldo, Quezon City, Philippines, represented in the act by its President, ARCHIMEDES H VIAJE, PhD, MNSA, President, herein referred to as the "ENTITY".

AND

PRINCE MOTOR CORPORATION, a corporation duly registered under the laws of the Republic of the Philippines with principal office address at 43 Commonwealth Avenue, Brgy Holy Spirit, Quezon City represented herein by its Sales Manager, MS SHERILL C MERDEGIA herein referred to as the "SUPPLIER".

WHEREAS, the Entity invited Bids for certain goods and ancillary services viz., Procurement of Two (2) units Mini Buses and One (1) unit Multi-Purpose Vehicle for the National Defense College of the Philippines has accepted a Bid by the Supplier for the supply of those goods in the sum of EIGHT MILLION FOUR HUNDRED NINETY NINE THOUSAND PESOS ONLY (P8,499,000.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a) The Bid Form and the Price Schedule submitted by the Bidder;
 - b) The Schedule of Requirements;
 - c) The Technical Specifications:
 - d) The General Conditions of Contract;
 - e) The Special Conditions of Contract; and
 - f) The Entity's Notification of Award.



3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the following items:

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
- Supplier are hereby required to deliver the award items within ninety (90) days.
 Failure to deliver shall constitute liquidated damages as per Special Conditions of Contract number 19-1 in the bidding documents.
